3-4 year-old Funding

The government provides Early Years Funding for children starting from the term after their 3rd birthday. This funding is designed to offer **15 or 30 hours per week** of **free**, **high-quality**, **flexible childcare during term time**. (Standard Offer - 15/30 hours term-time across 38 weeks, Stretched Offer - 11.18/22.35 hours across 51 weeks).

Please note that the funding **does not cover the cost of meals, consumables, or any additional hours** beyond the funded entitlement.

- **15 hours of funding** is available to all eligible 3–4-year-old children.
- To access the **additional 15 hours (totalling 30 hours)**, families must apply online to check eligibility. Generally, both parents must be working **at least 16 hours per week** and earn **below a certain income threshold**.

To access any funding entitlement, a **completed funding form** must be returned to the setting at the time of application or when the child becomes eligible.

<u>9 Months – 2 years old Funding</u>

We also accept **funding for eligible two-year-olds and children from 9 months old**, based on government schemes. To qualify, families must meet certain eligibility criteria set by the Local Authority. If eligible, you will receive an 11-digit eligibility code. You must confirm your code, national insurance number and child's date of birth so we can check that the code is valid.

These entitlements are offered **completely free**, and we **do not charge any "top-up" fees** to cover the difference between the government funding and our standard hourly rate. However, please note that **any additional hours beyond the funded entitlement**, as well as the cost of **meals**, **consumables**, or extra activities, will be charged separately.

If you believe you may be eligible or would like support in checking your entitlement, our Nursery Manager will be happy to help.

Additional hours will be charged according to the following table:
